#### HISTORICAL HIGHLIGHTS

The Physical Therapy Learning Institute was founded by Dr. Geneva R. Johnson PT, PhD, FAPTA and Dr. Lynda Woodruff PT, PhD, FAPTA, in 1991, as the Peach Blossom Learning Institute, to provide a forum for generating new ideas related to the evolution of the profession and a platform for the discussion of the future of physical therapy.

The name of the organization was changed to the Physical Therapy Learning Institute to continue supporting the development of the DPT and to advocate for the role of the physical therapist as a primary care practitioner.

1992-2004 The Board of Directors of the Institute led ten workshops focused on problem-based learning, promotion of the Doctor of Physical Therapy (DPT) as the entry degree, and

primary care in physical therapy.

2007 PTLI incorporated as a not-for-profit organization. The Geneva R. Johnson Library was

created at the University of the Incarnate Word (UIW), San Antonio.

The "Geneva R Johnson Forum for Innovation in Education" was inaugurated as the keynote

each year at the Education Leadership Conference.
